



RESOLUTION NO. 2022-0471

**AUTHORIZING THE RELEASE OF THE RESULTS OF THE APRIL 9 AND 10, 2022
PNP ENTRANCE AND PROMOTIONAL EXAMINATIONS**

WHEREAS, Section 21 of Republic Act (R.A.) No. 8551, otherwise known as the "PNP Reform and Reorganization Act of 1998" amending Section 32 of (R.A.) No. 6975, provides that the National Police Commission (NAPOLCOM) shall administer the entrance and promotional examinations for policemen on the basis of standards set by the Commission;

WHEREAS, in compliance with the foregoing mandate, the NAPOLCOM administers the PNP Entrance and Promotional Examinations twice a year;

WHEREAS, on April 9 and 10, 2022, the Commission administered the PNP Entrance and Promotional Examinations in twenty-two (22) examination venues nationwide;


WHEREAS, to determine the fixed level of passing in the PNP Entrance and Promotional Examinations, the NAPOLCOM has adopted the following Resolutions:

- A. *Resolution No. 2000-173 – Providing For A Fixed Level of Passing For All The PNP Entrance and Promotional Examinations Administered By The Commission;*
- B. *Resolution No. 2006-043 – Amending Resolution No. 2000-173 Providing For A Fixed Level of Passing For All The PNP Entrance and Promotional Examinations Administered By The Commission And Raising The Cut-Off Scores Of All The Examination Categories; and*
- C. *Resolution No. 2006-075 – Amending Resolution No. 2000-173 Providing For A Fixed Level of Passing For all The PNP Entrance and Promotional Examinations Administered By The Commission And Raising The Cut-Off Scores Thereof.*

NOW, THEREFORE, the Commission, **HAS RESOLVED TO APPROVE, AS IT HEREBY APPROVES**, the release of the results of the April 9 and 10, 2022 PNP Entrance and Promotional Examinations with the statistics of the examinees who passed and failed, the fixed level of passing, and the passing rate per examination title, as enumerated hereunder:
